

Fourth Grade Tino




Tino has a dapple dachshund. Tino said his dog is crazy (in a loving way).

Ron and Carol Wirths

This is probably one of the easiest interviews I have ever done – Ron & Carol had nearly everything written up. It didn't leave many questions for me to ask. Ron would respond, "It's in there" and so it was! Here is what they wrote.

Ron and Carol came to Albuquerque by way of Wichita, Kansas. Ron was born there and Carol's family relocated to Wichita from Enid, Oklahoma when she was five years old. They first met in accounting class at Wichita State University, and both graduated with degrees in accounting in 1973. (*My first question was how did they do this when Ron is older than Carol. He did his military service stint following his dad's belief in work versus college.*) Ron graduated cum laude and Carol graduated summa cum laude. So, we know who is the smarter one.

Ron was the third of eleven children in a devout Catholic family. His father owned a construction company and a wood products company. (*His brothers joined the family business and branched out but Ron took a different route.*) He attended parochial schools from grade school through high school. After high school, with his number coming up during the Vietnam War, he elected to join the Air Force. His training was as a linguist, and he spent two years in Turkey as a Bulgarian/Russian linguist – the specifics being classified.

Carol grew up with a younger sister and attended school in Haysville, Kansas. Her father worked as a sheet metal mechanic at Boeing and her mother was a cook for the public school system. Theirs was a devout Lutheran family. (Her parents grew up during the depression. Her dad lived in a small Mennonite community. Her mom grew up on a farm.)

Carol's first job after graduation was with Boeing in Wichita as an auditor. She convinced Ron, who had been working in the family construction business, to apply there also. They both became gainfully employed in the Finance Department at Boeing-Wichita.

They married on December 28, 1974 –you might note they celebrated their 50th anniversary in December 2024. Their first son, Jeremy, was born in 1977, with a second son, Jared, arriving in 1981. They decided it would be best for the boys if Carol took a sabbatical from work during their early childhood years. It was a great decision for all concerned. The money was tight, but the boys grew up much happier and well-adjusted. Ron was able to concentrate on his career without the worry of chasing daycare, appointments or school trips (*which we agreed is the complex role of today's parents.*) Carol enjoyed her roles as room mother, Sunday School teacher, and cub scout leader while the boys were young. She returned to work when the boys went to middle school.

In 1991, Ron had an opportunity to transfer to Macon, Georgia as business manager of a Boeing manufacturing facility. After much discussion and anxiety about leaving their close family connections, they made the move. It turned out to be one of the best things they had ever done. Life in the deep South was very different from the somewhat insular environment in Kansas. After surveying the educational opportunities in Macon, they discovered there were a couple of exclusive private schools and several underfunded, unimpressive public schools. The nearby city of Warner Robins, which was anchored by the Air Force Base of the same name, offered top notch public schools with lots of extracurricular programs. The commute to Macon was only twelve miles. The decision was made and they moved to Warner Robins, Georgia. They enrolled the boys in schools that were far more diverse than anything they had experienced in their short lives.

This early focus on education paid dividends in later years. Jeremy was a National Merit Scholar Finalist and went on to garner a BA in music, a BA in Vocal Performance, a Master's degree in Organ and Sacred Music, a Master's degree in Choral Conducting, a Doctor of Musical Arts, a Master's in Business Administration, and a Law degree. Jared earned Bachelor degrees in both Economics and Accounting. *(Ron and Carol couldn't be prouder parents.)*

Carol was employed as a financial aid counselor at Mercer University Medical School during their stay in Georgia. Then in early 1997, Ron was informed that Boeing wanted to shutter some of its smaller operations and Boeing-Georgia was on the chopping block. With only 1,200 employees it was a minor player in the aerospace manufacturing arena. Ron and Carol chose to return to Boeing in Wichita. Ron became business manager for the machining fabrication business unit, and Carol resumed her career at Boeing as a cost analyst for government contracts.

In 2002, with the airline industry in disarray after the 9/11 attacks, Ron took advantage of an early retirement offer (*at the ripe age of 58*). Carol continued working until she reached age 55. In their early retirement years, they busied themselves with volunteer activities. Carol worked as a designated payee at Episcopal Social Services – an organization serving clients receiving Social Security Disability payments who had no trusted financial advisor or family to manage their affairs. Ron worked as a volunteer income tax preparer. He also was active in maintaining property at their church.

They had often talked about relocating to another state in their retirement years. Following the deaths of both of their mothers in the 1990s, they found themselves being primary caretakers for their widowed fathers, neither of whom would remotely consider moving. Both their fathers passed away within months of one another in 2013.

Now was the time to explore a more desirable place to live. At that time, Jeremy had recently moved to Albuquerque with his partner James. Jeremy practices family law in Albuquerque and Santa Fe, while also being Music Director at Saint Mark's Episcopal Church in Albuquerque. His partner, James, is a pediatric neurosurgeon on the faculty at UNM. Their son Jared is an accountant at Saint Monica's Catholic Church in Dallas – a congregation of 12,000 parishioners, 100 employees and a K thru 8th grade school with 750 students. Jared's wife Barbara is a bilingual kindergarten teacher in the public school system, and they live in Allen, Texas. At the time of deciding to move Ron and Carol's two grandchildren, Matthew (now almost 4) and Dorothy (now 2) had not arrived on the scene.

Ron and Carol wanted to be near family when they relocated. They preferred moving to New Mexico rather than the Dallas area which they felt would be hard to navigate, particularly as they became older. Originally, they planned to move to Santa Fe. They abandoned that idea after a failed real estate deal. They visited Del Webb Mirehaven, a fifty-five and over community in Albuquergue, and thought it would be a suitable opportunity. It has turned out to be a remarkably wise decision. With everyone in the same age and socio-economic group, it has been easy to adapt to a common active lifestyle. The Friday night happy hour sessions provide opportunities to share the varied experiences senior citizens have had raising families, traveling and pursuing careers. As Ron noted, having a rudimentary understanding of weather or geriatric ailments gualifies him as a sparkling conversationalist at the Amenity Center. Ron has two favorite hobbies, fishing and tormenting his sons with unsolicited advice. The first he does less than he wants, and the second he does more than he should. He is also part of a small group that hikes and then explores the 'best' green chile cheeseburger in the area. Ron also volunteers as part of a group that monitors the landscaping needs of the community common areas. Ron likes to point out that his group has reduced water consumption by 4.5 million gallons per year since taking over the process. (You would think he was an engineer! A great accomplishment.) Carol is in a neighborhood book club and stays engaged in exercise classes and social activities. Ron also serves on the Cross of Hope Council.

They attend the first service. Seek them out for a pleasant and fun chat. Be careful of Ron, you might find yourself seeking out a green chile cheeseburger or on a hiking trail.




